

## Family Justice Centre - Parenting After Separation

The task of continuing to parent while working through the legal, emotional, social and financial turmoil of the separation process can be very difficult. Workshops available in New Westminster, and Vancouver assist families through this process. The goals of these workshops are to attempt to reduce the stress of the process for families and assist them in moving forward with their lives. Topics include:

- The court process, the mediation process and the role of the Family Justice Counselor.
- The child and parent's experiences of the separation process.
- Strategies to help yourself and your child through this process.
- When and how to seek professional help for your child or yourself.
- Effective ways to communicate and problem solve, building a positive co-parenting relationship.
